



PRIVATE AGREEMENT
ASOCIACIÓN EDUCACIONAL WILLIAMSON DEL PERÚ

ASSOCIATE, PARENT OR LEGAL GUARDIAN

The associate, parent, or legal guardian signing this document does so in accordance with the provisions of the Private Educational Institutions Act No. 26549, as amended by Emergency Decree No. 002-2020 and Supreme Decree Regulation No. 005-2021-MINEDU, Article 53, in line with Act No. 27665, the Family Economic Protection Act, regarding the payment of tuition fees in private educational centres and programmes, which amends the aforementioned Act No. 26549 and Ministerial Resolution No. 556-2024-MINEDU.

FIRST: I DECLARE that I am aware of the purpose and philosophy of Newton College, as well as the principles, goals, and objectives established in the Internal Regulations of the Educational Institution; expressing my commitment to adhere to and respect the aforementioned philosophy, principles, goals, and regulations, which means that, in accordance with Article 14 of the Political Constitution of the State, education is provided at all levels in compliance with the institutional principles and the corresponding objectives of the educational institution.

SECOND: I DECLARE that I am aware of the information provided by the school regarding the cost of the educational service for the year 2025, and I commit to honouring the payment of the monthly fees (equivalent to the tuition fees) by the last day of each month. I acknowledge that the school's operational and investment budget is primarily funded by the monthly fees, which in turn cover the salaries of the teaching, administrative, and service staff, as well as the acquisition of goods and payment of services (electricity, water, telephone, etc.); and that timely and prompt payment of these fees avoids interest and charges as stipulated by law.

THIRD: I DECLARE that I am aware that the amount of the monthly fees of the associate, equivalent to the tuition fees for the year 2025, may be increased in accordance with institutional needs, inflation, and/or the increase in prices of goods and services necessary for the continued provision of the educational service.



FOURTH: I DECLARE that I am aware that the accident insurance for students, which the school may offer, is optional and voluntary for the associate, parent, or legal guardian.

FIFTH: I DECLARE that I am aware of the current legal regulations applicable in the event of withdrawal or transfer of my child or the minor under my custody, regarding the proportional refund of the admission fee paid to the Association; and, I expressly commit not to make any requests or claims to the school or the *Asociación Educativa Williamson del Perú* that are not considered by the current legal regulations.

SIXTH: I DECLARE that I am aware that the *Asociación Educativa Williamson del Perú* or the school has the authority to withhold the student's academic certificates for unpaid periods and/or not to confirm the student's enrolment for the following year due to late payment of the monthly fees of the associate, equivalent to the tuition fees, for the educational service provided during the 2025 academic year.

SEVENTH: I ACCEPT that failure to pay the associate's monthly fees, equivalent to the tuition fees, will result in a monthly late payment interest established by the *Banco Central de Reserva del Perú*, for transactions between parties not involved in the financial system.

EIGHT: I CLARIFY that the person responsible for the payment of the associate's monthly fees, equivalent to the tuition fees, and other charges mentioned above, is [LAST NAME AND FIRST NAME OF THE ASSOCIATE].

NINTH: I ACKNOWLEDGE AND ACCEPT that account statements, collection notices, and appointments with the administration to discuss financial matters will be sent to the email addresses of both parents.

TENTH: I DECLARE that the main means of communication between Newton College and the parents is the INTRANET, which can be accessed from the institution's website using the family's username and password. I commit to reviewing and reading all the information provided by the institution daily.

ELEVENTH: I ACKNOWLEDGE that parents are the primary responsible parties for the education of their children and commit to participating in the educational process of my minor child(ren), as provided by the educational institution. This includes attending academic, formative, and recreational activities to which I am invited, as well as informational talks, conferences, or meetings organised by the school. I also commit to fulfilling the obligations assumed in cases of family therapy and external support for my child(ren) when required by the institution. Additionally, I commit to sharing reports from external specialists with our Student Engagement Department to work as a team for the well-being of the student.

TWELFTH: I ACKNOWLEDGE AND ACCEPT that at the time of signing the Agreement, the ASSOCIATE has accessed the family intranet and has viewed, read, and downloaded all the documents that parents must be aware of through it, including: Operating Licence, Director's Resolutions of Authorisation, Enrolment Circular, cost of tuition fees and registration fees, amount and payment deadlines for the registration fee, required documentation for the enrolment of new students, Institutional Curricular Plan, academic calendar, number of students per classroom, class schedule, number of vacancies, Institutional Educational Project, School Coexistence Policy, Guide for parents on how to act in cases of school violence, Guide for students on how to act in cases of school violence, Internal Regulations, Emergency Communication Plan, Professional status of the Director, senior staff, and teachers, Information about the promoter and the Director, Ethical Guide for parents, Data Protection Policy, ARCO Rights, Authorisation and consent for the taking and use of photographs, publication of images



and videos, Ethics Committee Regulations, Statutes of the Williamson Educational Association of Peru, Statutes of the Newton College Parents and Teachers Association.

THIRTEENTH: I ACKNOWLEDGE that, in accordance with current legal provisions, within the framework of curriculum diversification and the free allocation of one-third of curriculum hours that the educational institution is authorised to manage, the distribution of hours may be modified during the academic year in an effort to optimise the educational service, ensuring that the minimum hours established for each educational level are met.

FOURTEENTH: I COMMIT not to involve the educational institution in any judicial or extrajudicial processes regarding the custody and visitation arrangements of my child(ren).

FIFTEENTH: I ACCEPT AND ACKNOWLEDGE that the provisions contained in this Agreement are mandatory for compliance, as they constitute a voluntarily assumed commitment, which I ratify by signing as a sign of agreement.
